Dear Alan.

Thank you for allowing us to present you with a pest control proposal for your facilities in Topeka.

Ozark has been servicing facilities like yours for over 40 years in Topeka, Lawrence, and surrounding areas. Some examples are Briggs Dodge, Kansas Turnpike Authority, FedEx, and several others. We currently have nine service technicians of which seven are certified with the State of Kansas.

Our services will include treating the interior and exterior entry ways of all listed buildings for the control of most insects and mice. On the initial visit, our technicians will ensure that there are enough exterior rodent stations around each building and, add stations where we feel they are needed. With this service we offer free recall services in the event you develop a pest problem in between service dates.

The initial visit will include chemically treating all entry ways, restrooms, mechanical areas, and any potential pest entry points to help prevent pests. Our technician will also place insect monitors and rodent bait stations where needed. Each monthly visit our treatment methods will consist of inspection, exclusion, and then localized chemical treatments with the goal of keeping your facility pest free.
